

THE COURT ORDERS THAT:

1. In each of proceedings B48/2024, B49/2024 and B50/2024, pursuant to r 27.08.1 of the *High Court Rules 2004* (Cth), the questions of law stated by the parties in the special case be referred for consideration by a Full Court on a date to be fixed.
2. All documents filed in proceeding B48/2024 be taken to be filed in proceedings B49/2024 and B50/2024.
3. Part 44 of the *High Court Rules 2004* (Cth) applies, with variations as to dates listed in orders 4–12 below.
4. By 4pm on Wednesday 15 January 2025, the appellants file a notice of constitutional matter in accordance with r 5.01 of the *High Court Rules 2004* (Cth).
5. By 4pm on Friday 17 January 2025, the appellants file an affidavit of service of the notice of constitutional matter in accordance with r 5.03 of the *High Court Rules 2004* (Cth).
6. By 4pm on Friday 24 January 2025, the appellants file and serve a special case book.
7. By 4pm on Monday 24 February 2025, the appellants file and serve written submissions of no more than 20 pages.
8. By 4pm on Wednesday 5 March 2025, any intervener in support of the appellants file and serve written submissions of no more than 20 pages.
9. By 4pm on Monday 24 March 2025, the respondent file and serve written submissions of no more than 20 pages.
10. By 4pm on Wednesday 2 April 2025, any intervener in support of the respondent, or in support of neither party, file and serve written submissions of no more than 20 pages.



11. By 4pm on Wednesday 16 April 2025, the appellants file and serve written submissions in reply of no more than 5 pages.
12. By 4pm on Tuesday 22 April 2025, the appellants file and serve a joint book of authorities, prepared in accordance with Practice Direction No 1 of 2019.
