### Inspecting a file

There is a \$32.00 search fee to inspect the file, this gives you access for 1 hour to the file. You will be asked if you wish to proceed to viewing the file, if you accept and continue you will be asked to pay by credit card before access is granted:

The fee for Searching or inspecting a document mentioned in rule 4.07.4 of the High Court Rules 2004 is \$ 32 for each hour or part of an hour.

If you click proceed, you will be pay the first hour's fee by credit card.

If you do not wish to incur the \$ 32 fee or do not have a credit card available please cancel this request.

There is an additional fee of \$4.00 per page to download any document inspected.
